

*The following notices of motion will be voted on at a duly called business meeting after the worship service on Sunday March 23rd:

- That our church constitution be changed in the following way: Whereas it **currently** reads regarding the Management Board, *“the Management Board shall meet at least **eight** times per year...”*

I (Pastor Sam) move that the constitution be changed to read,

*“The Management Board shall meet at least **Six** times per year...”*

- That our church constitution be changed in the following way: Whereas it **currently** reads under article 9, section 5, *“A quorum for the commencement of business of business at the Annual Business meeting shall not be less than twenty members of the church. Such meetings may continue and business may be duly transacted as long as fifteen or more members of the Church remain in attendance.”*

“A Quorum for the commencement of business at duly called business meetings shall not be less than fifteen members of the Church. Such meetings may continue and business may be duly transacted as long as ten or more members of the Church remain in attendance.”

I (Pastor Sam) move that the constitution be changed to read: *“A Quorum for the commencement of business at the Annual Business meeting and duly called business meetings shall not be less than fifteen members of the Church. Such meetings may continue and business may be duly transacted as long as twelve or more members of the Church remain in attendance.”* Revised in 2013 when average attendance is around 30. (It is recommended that when average attendance is much higher, the quorum number be reviewed.)”

- Whereas our Church Covenant **currently** reads: *“We also engage...to abstain from the sale and use of intoxicating drinks as a beverage...”*

I (Pastor Sam) move that this item of our Covenant be changed to read as follows: *“We also engage...to seek God’s help in abstaining from all drugs, food, drink, and practices which bring unwarranted harm to the body or jeopardize our own or another’s faith...”*

- Notice of motion brought forward at the annual meeting February 19 reads:

Ralph DeLong moves that article 5 section 9 in the constitution be removed and the duties of the parsonage committee be put under the trustees in section 10.
